Sub:- Creation of posts on contractual basis under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G).

In continuation of this department memo.No.IAY-2016/1339, dated 21.03.2016 on the subject cited above.

As per instructions of Ministry of Rural Development, Govt. of India issued vide their letter No.M-13011/05/2013-RH, dated 13.7.2015 and as per provision in para 3.6 of IAY guidelines, following posts at district and block level were sanctioned with the concurrence of Finance Department, Haryana vide their U.O.No.53/70/2015-2FD1/18418, dated 15.9.2015 on contractual basis:-


Block Level

1	Co-ordinator	1	Rs.25,000/-	Post Graduate degree in Rural Development/Economics/Social Work or its equivalent with 55% marks having knowledge of computer and one year experience in Govt./Semi sector in the relevant field. OR Post Graduate diploma in Rural Development or its equivalent with 55 % marks having knowledge of computer and 2 years experience in Govt./Semi sector in the relevant field .

Accordingly, all the DRDAs were requested to fill up one post of Co-ordinator at district and one Co-ordinator at block level, if required, @ 2% expenses under IAY Scheme for a period of one year on contract basis through advertisement with the condition that these posts are not regular posts and these incumbents do not have any right for regularization. One post of Data Entry Operator at district level may also be filled up, if required, through HARTRON on contract basis.

From the year 2016-17, Indira Awaas Yojana has been revamped as Pradhan Mantri Awaas Yojana-Gramin. Therefore, the above structure set up for IAY may be converted into Programme Management Unit (PMU) under Pradhan Mantri Awaas Yojana-Gramin.

You are therefore, requested to take necessary action accordingly.
